## CCPS hosts 2nd annual job fair

Nearly 75 teacher hopefuls interviewed for jobs on June 7 at the Charles County Public Schools second annual Job Fair.

Keith Hettel, Assistant Superintendent of Human Resources called the daylong event at La Plata High School a success. He said 20 candidates were

offered positions, with 10 accepting jobs as of Wednesday. "We expect to hear from the others this week," he said.

Most offers were made in the school system's critical areas, which are high school and middle school special education, math, science, Spanish, art, and music.

Elementary candidates were interviewed; however, there are no elementary teacher openings at this time. Tenured teachers may resign up until July 15, so interviews were held to develop a pool of possible future hires, Hettel said.

Candidates were from 13 states including in-state candidates from Maryland and

ones from as far away as Texas, Wisconsin, Illinois and the U.S. Virgin Islands. Principals and vice principals from each school conducted the interviews.

Teacher candidates are given the opportunity to sign up for interviews and also meet with Human Resources staff to learn about other issues.

## Top vice principal known for love of children, education

Deborah Brown, vice principal at Dr. Gustavus Brown Elementary School, was selected as the 2008 Charles County Public Schools Vice Principal of the Year.

"I am humbled to receive this award. Children and public education are my passion. I am truly honored to be nominated by my school staff for this award and am proud to be a part of a system that promotes excellence," Brown said.

## Board holds work session

The Board of Education will meet on Monday, June 23, 6 p.m., at Maurice J. McDonough High School. Agenda items include approving alignments to the fiscal year 2009 budget and the schematics for full-day kindergarten additions and renovations at Dr. Gustavus Brown, Indian Head, Arthur Middleton and Eva Turner elementary schools. There will also be a closed executive session to discuss personnel.

## Board approves textbook

The Board of Education approved a new textbook for use in the Teaching as a Profession Foundations of Curriculum and Instruction course. The book, "Learning to Teach" by Richard I. Arends and published by McGraw Hill, will be used at all high schools. The cost of the 180 textbooks is \$17,213. The Teacher Academy of Maryland program was developed in coordination with the Maryland State Department of Education and the Maryland Association of Community Colleges.

## Larson learns Bach

Katherine "Katy" Larson, an ESOL (English as Second Language) teacher at North Point High School, was recently selected to attend the "J.S. Bach in the Baroque and the Enlightenment" summer institute to be held in Germany. The four-week institute is one of 27 summer study opportunities provided by the National Endowment for the Humanities. The institute's focus is on the music of J.S. Bach and how it relates to the knowledge and belief system of the 18th century.



## Tuition reimbursement

Tuition reimbursement for all employees must be submitted no later than June 30 for courses completed during the 2007-08 school year, which is July 1, 2007, to June 30, 2008. If grade slips or official transcripts are not available by the deadline, requests must still be submitted by June 30, and reimbursement will be held until original grade slips, transcripts and documentation of tuition fees are submitted to human resources.

Classes starting after July 1 will be charged to the 2008-09 tuition reimbursement allotment. All courses must be preapproved by human resources.

Paul Barnhart Elementary School; Pamela Jenkins, instructional assistant, Dr. James Craik Elementary School; John Lancaster, building service manager, Milton M. Somers Middle School; George Risko, HVAC Mechanic, Radio Station Road Annex; and Sandra Shegogue, secretary, Piccowaxen Middle School.

Deese is the 2008 Outstanding Food Service Worker. She has been the food service manager at Barnhart for the past two school years and was

nominated by Patrick Tague, the supervisor of food services for CCPS. Barnhart Principal Timothy Rosin said Deese is a "highly effective leader" and that she was instrumental in the establishment of the Maryland Meals for Achievement (MMFA) program at the school. "She and her staff daily prepare trays of these breakfasts, which are then delivered to each of the classrooms so students can start their day off in a healthy way," Rosin said in a nomination letter.
