School system launches parent communication site

Charles County Public Schools is launching a new parent communication system called Edline on Monday, Sept. 20. The site is a secure, Internet-based system parents and students can use to keep up-to-date with their child's records and classes. To access the system, parents will need to obtain an account activation code from their child's school. The system is available 24 hours a day, seven days a week.

Teachers will now have the ability to create classroom pages, post lesson plans and homework assignments, as well as educational links for students. Each teacher is assigned a page for each class. All school sites are accessible to parents from the Charles County Public Schools Web site, www.ccboe.com. To access the sites from the school system Web site, select the schools and centers tab located on the left-side navigation bar

on the home page.

Staff in the school system's communications department will continue to oversee and manage the school sites, and Web masters at each school update content included on each site. Additionally, data processing department staff manages student data, records and account activation.

The grading review system replaces the Parent at School program that was disabled two years ago due to security problems.

Middle and high school parents can now view their child's grades, class information, calendar of events and activities, and schoolrelated news and updates. The system will be used by the school system and schools to also send e-mails and telephone updates to parents. This feature will be implemented in the coming months.

Primary leaves 14 candidates vying for Board seats

The race for the Board of Education was narrowed to 14 candidates Tuesday evening. A primary election eliminated the five candidates with the lowest vote totals. Voters will now select seven from the field of 14 on General Election Day, Nov. 2. The new Board of Education will be sworn in to office 4 p.m., Dec. 20, at North Point High School.

Five incumbent Board members, Jennifer Abell, Maura Cook, Pamela Pedersen, Donald Wade and Roberta Wise, were among the 14 that voters selected to advance to the general election. Results are still unofficial. Two incumbents, Collins Bailey and Charles Carrington, did not run for re-election to the Board.

Maryland added early voting for the first time this year. Early voting for the 2010 General Election is Oct. 22, 23, 25, 26, 27 and 28, 10 a.m. until 8 p.m., at the Charles County Board of Elections building in La Plata. On Nov. 2, polls open at 7 a.m. and close at 8.p.m.

Class of 2010, high schools improve average SAT scores

Charles County Public Schools average score on the SAT, a nationally known college entrance test, is 1486, an increase of 22 points above last year's average. SAT scores at each of the six county high schools improved in 2010.

Students' average score on the critical reading section is 502, an increase of nine points from last year. Math scores improved to 497, with a seven point gain and writing scores increased six points to 487. SAT tests are designed to demonstrate a student's mastery of certain subjects to colleges. Many colleges use the test as a part of the admissions process.

Only scores for graduating seniors are included in the 2010 report. Students in the Class of 2010 were offered more than \$37 million in scholarships.

La Plata High School was the highest performing school with a score of 1645. Maurice J. McDonough High School students posted an average score of 1524 and Westlake High School students posted a 1501 average. Thomas Stone High School students' average score is 1471, North Point High School's average score is 1445 and Henry E. Lackey High School students averaged 1403. Average participation countywide is 35.7 percent, down from

39.8 percent in 2009.

Last fall, Charles County Public Schools began offering Kaplan Live Online, an interactive SAT preparation class, for seniors. In the spring, the opportunity was extended to juniors. The sessions were offered on Saturdays at three regional sites. The school system is again offering a Saturday Kaplan Live Online course for seniors this fall, and juniors will be able to participate in Saturday sessions in the spring. Additionally, each high school will offer a 50-hour Kaplan online course through an SAT prep course or after-school learning opportunity. The school system offered five, weeklong SAT preparation classes during the summer.
