Definition of Homelessness

The federal McKinney-Vento Education of Homeless Children and Youth Assistance Act defines homeless children and youth to be those who lack a fixed, regular, and adequate nighttime residence.

This includes children and youth:

- Sharing housing due to a loss of housing, economic hardship, or a similar reason.
- Living in motels, hotels, trailer parks, or camping grounds due to a lack of alternative, adequate housing.
- Abandoned in hospitals.
- Living in emergency or transitional shelters.
- Living in a public or private place not designated for or normally used for sleeping such as cars, parks, public spaces, abandoned buildings, substandard housing including no water or electricity, etc.
- Who qualifies as a homeless unaccompanied youth.
- Who are migratory/living in above circumstances.

Educational Rights of Homeless Students

Eligible students have the right to:

- Equal access to the same free, appropriate public education, including a public preschool education.
- Immediate enrollment even if lacking required documents for registration.
- Attend classes and fully participate in school activities while the school arranges to obtain required school and immunization records, and other documents as needed.
- Continue attending the school of origin for the duration of homelessness, and until the end of the academic year in which the student becomes permanently housed; or
- Enroll in the public school in the attendance area where the student is living and eligible to attend with in his/her best interest.

Educational Rights of Homeless Students (con't)

- Receive transportation services to and from the school of origin, if requested and within his/her best interest.
- Attend classes and fully participate in school activities while the school and parent/guardian/unaccompanied youth seek to resolve a dispute over school enrollment.
- Receive free school meals, receive assistance to prepare and improve college and career readiness and participate in school-related and extra-curricular activities; and
- Access to educational and other services the student needs to enable them to meet the same challenging state academic standards to which all students are held.

Dispute Resolution Process

If a dispute arises regarding services for a homeless student, the parent/guardian/unaccompanied youth must file their dispute with the appropriate school principal in writing within 10 days.

- The principal shall issue a written decision within five school days.
- If dissatisfied with the decision, this decision may be appealed in writing within 10 school days to the school system homeless liaison who serves as the superintendent designee for displaced students. The homeless liaison must issue a decision within 10 school days.
- If dissatisfied with the decision, this decision may be appealed to the local school board, in writing, within 30 days. The local board shall decide the appeal on an expedited basis within 45 days of receipt of the appeal.
- If dissatisfied with the decision of the local board, the decision may be appealed to the State School Board, in writing, within 30 days.

Dispute Resolution Process (con't)

During the dispute resolution process, including any appeals, the student shall remain enrolled in the school system. The student has a right to:

- Enroll or continue at the school in which enrollment is sought, pending resolution of the dispute; and
- Receive transportation services to the requested school for the duration of the dispute resolution process.

Best Interest Determination Factors

To consider if it is in the student's best interest to remain at their school of origin, or to attend the school in the attendance zone where they currently reside. Factors include:

- The student's age.
- The school which the student's siblings attend.
- The student's experiences at the school of origin.
- The student's academic needs.
- The student's emotional needs.
- Any other special needs of the family.
- Continuity of instruction.
- Length of stay in the shelter.
- The likely location of the family's future permanent housing.
- Time remaining in the school year.
- Distance of commute and the impact it may have on the student's education and other student-centered, transportation-related factors; and
- The safety of the child.
