Martin to be honored for gifted education program

T.C. Martin Elementary School was recently named a recipient of the Maryland Excellence in Gifted and Talented Education (EGATE) award by the Maryland State Advisory Council on Gifted and Talented Education. The recognition program honors elementary, middle and high schools that offer gifted and talented programs that model excellence and focus on improving levels of student achievement.

T.C. Martin is one of eight Maryland schools that received the EGATE award this year. Martin is Charles County's third elementary school to receive the award recognition. Last year, Dr. James Craik and William B. Wade elementary schools received the EGATE designation. The school will be honored at a state reception Feb. 28 at Johns

Hopkins Applied Physics Laboratory. As an EGATE recipient, Martin will receive a Governor's citation, EGATE school banner and plaque.

The program was launched in 2010 by the Maryland State Department of Education and the State Advisory Council on Gifted and Talented Education. To be considered for the program, schools submit a comprehensive application that includes documentation that demonstrates their program is aligned with criteria outlined in the Maryland Criteria for Excellence: Gifted and Talented Education program guidelines.

In addition to recognition, Martin will serve as a model EGATE school and must reapply every fourth year in order to maintain its EGATE status.

Two teachers named Outstanding Gifted Educators

Two Charles County Public Schools gifted education resource teachers, Joyce Campbell and Mary Seremet, were recently named Outstanding Educators in Gifted and Talented Education - Teachers as Leaders – by the Maryland State Department of Education's (MSDE) Maryland Advisory Council on Gifted and Talented Education. The Maryland State Advisory Council on Gifted and Talented Education annually honors educators, students and community organizations for their contributions in developing the talents of Maryland students in gifted education.

Campbell and Seremet are both gifted education resource teachers at the Jesse L. Starkey Administration Building, and were nominated for the award by Maryann Bourassa, content specialist for gifted educa-

tion for Charles County Public Schools. Campbell works with a group of 15 gifted education resource teachers that serve the county's 21 elementary schools. She meets with them monthly to share information, discuss gifted identification processes, review data, provide professional development and serves as a leader for the elementary gifted program.

Campbell also works with resource and classroom teachers to help them adapt and develop curriculum for gifted students, and is the Destination Imagination regional director for Charles County. In her nomination statement, Bourassa said Campbell is highly respected among her peers. "Joyce has earned great respect from the teachers who work with her. The gifted staff depends on her extensive knowledge of gifted issues and her calm demeanor to provide guidance and support whenever needed," Bourassa said.

Campbell said she is honored to receive an award for her work in gifted education, and appreciates the support of school system leaders in expanding the program. "I work with wonderful gifted resource teachers in our schools who really are the ones

that have made the gifted program in our county an outstanding program. I appreciate the support that Mr. James Richmond and Mrs. Judy Estep have given to help expand the gifted programs in our county,"

she said.

Seremet works with the gifted resource teachers at the county's eight middle schools. In addition to meeting with these teachers monthly to review data and share information. Seremet also works with

middle school reading and language arts teachers who work with advanced-level students. In her nomination statement. Bourassa said that Seremet is a continuous supporter of gifted education.

"The teachers who work with Mary have great respect for her professionalism and dedication to gifted education. Her expertise and passion are evident in her work," Bourassa said.

Seremet said she is honored to be nominated for the award. "I am honored to have been nominated for this award and feel privileged to be part of a school system that not only values but celebrates gifted education. With the leadership of Mr. Richmond and Mrs. Estep and the dedication of gifted resource teachers in every middle school, CCPS continues to demonstrate our commitment to providing exemplary gifted education programs for our students," Seremet said.

Last school year, Campbell and Seremet worked together to teach a free session of MSDE's The Gifted Learner course in which 25 classroom teachers and administrators earned professional development credits. The course was offered at no cost to participants because Campbell and Seremet volunteered to teach the course with no compensation.

Campbell and Seremet are two of 20 educators in Maryland to receive the Teacher as Leader award this year. They will both be honored at a Feb. 28 state reception at the Johns Hopkins Applied Physics Laboratory.


