National Board Certified Teachers must complete a rigorous review of their skills and work, which includes teacher portfolios, student work samples, videotapes, and thorough analysis of the

candidates' classroom teaching and student learning. Teachers also complete a series of written exercises that probe the depth of their subject-matter knowledge and their understanding of how to teach that material to students.

These teachers join more than 4,000 teachers nationwide who were certified in 2014. Certification is valid for 10 years, after which a teacher may complete the renewal process. Maryland has 2,760 teachers who are nationally certified and is one of the top 10

states with the highest participation in the certification process.

achieving Bv National Board Certification, Charles County teachers are eligible for a stipend added to their annual salary as long as they maintain their National Board Certification status. Only teachers with a standard or advanced professional certificate who have a minimum of three years successful teaching experience are eligible to apply for National Board Certification. # CCPS offers gym discount; screening to promote employee wellness

Charles County Public Schools (CCPS) is offering discounted gym memberships at World Gym, health risk assessments and biometric screening to promote employee wellness and in partnership with Calvert Memorial Hospital. A kickoff enrollment session for the benefit, called KeepWell@Work, is scheduled for Jan. 19. Full-time employees (those who are eligible to receive CCPS health benefits) and their immediate family members (ages 12 and up) are eligible to participate. Program participants can also access weight management programs. A program kick-off enrollment session is scheduled for Jan. 19 from 10 a.m. to 4 p.m. at the World Gym location in La Plata.

The program features two enrollment sessions per year. The first session starts Jan. 19 and is available through Feb. 14. Another session is planned for July. These are the only two times that program participants can sign up. Eligible family members include any one who could be added to a CCPS-sponsored health benefit plan, such as a spouse and children up to age 26 (including adopted, stepchildren, or a disabled child with benefits who were enrolled prior to age 26). There are requirements for all employees, as well as participating family members.

#### These requirements include:

• The completion of an online health-risk assessment. This is required for everyone signing up and the fee is \$26 per person. Participants must first visit http://www.calverthospital.org/body.cfm?id=1288 to request the health-risk assessment. The assessment fee is waived for participants who sign up for the 12-month gym membership.

• All participants must attend an enrollment session. At this session, participants will complete the biometrics portion of the assessment, sign up for the gym membership (if interested) and complete the payroll deduction paperwork. A link to session information is posted on the CCPS employee portal, InsideCCPS. Participants can bring cholesterol and glucose screening information to the enrollment session to include it in their biometric screening. Results must not be older than three months prior to enrollment.

• The gym membership is not required. However, participation in an enrollment session and payroll deduction for the health assessment fee is required. The \$26 health assessment fee will be paid through payroll deduction at \$1.09 twice a month for 24 pay periods.

• Completion of all requirements by the enrollment deadline of Feb. 14. Participants who cannot attend any of the scheduled enrollment sessions can contact the Keep Well Center at Calvert Memorial Hospital to complete the sign-up process. Call 410-535-8233.

Total cost of the gym membership is \$240 annually per person, which would be charged at \$20 per month, per person, and paid for through payroll deduction at \$10 per pay for 24 pay periods. Deductions begin in March (for those who enroll in the first session) and September (for those who enroll in July). During months where there are three pay dates, no deduction will be made on the third pay date. All health-risk assessment and membership payments must be processed through payroll deduction. There is also a \$26 gym membership enrollment fee per person that must be paid at the enrollment session. Accepted forms of payment include cash, check or a credit card.

There is no limit to the number of family members that can sign up; however, once the deductions are processed they cannot be canceled until the end of any gym contracts. Employees who participate in the program must renew their program participation during the Keep-Well@Work enrollment period with CCPS held annually. Those interested in continuing with the program after the initial one-year period must also undergo a new health-risk assessment.

As part of the gym membership, participants are eligible for a fitness orientation with a personal trainer who will help them develop an exercise program. The gym membership is for use at the following World Gym locations: La Plata, Waldorf, Prince Frederick, Owings, California, Lexington Park, Leonardtown and Lusby.

Employees who already have a current gym membership/contract at the listed World Gym locations can sign up through the KeepWell@ Work program to access the reduced rate of \$20 per month. The existing gym contract will be updated with a new start date at the time of enrollment, and will continue with the new cost of \$20 per month for 12 months. These employees will also receive a new key tag for their new membership. The enrollment fee of \$26 will only be waived for employees who already have a long-term contract with World Gym (one year or longer).

#### Important notes about the program:

• Family members are only able to participate if the CCPS employee in their family participates.

• Full-time employees only have to be eligible for CCPS-health benefits to participate in the program – they do not have to use them to participate. CCPS employees are eligible for health benefits if they are hired in a permanent position and work at least 20 hours per week.

• Full-time employees who want to participate but do not use CCPSsponsored health benefits must contact Lori Gibson at lrgibson@ccboe. com in the office of human resources to be added to the participant list in order to sign up.

• Employee participation is a minimum of completing the online health-risk assessment, attending an enrollment session, completing the biometrics and signing up for payroll deduction (for the assessment fee if the gym benefit is not used).

• The CCPS employee must be present at the enrollment session for any family member to sign up.

• Gym membership includes unlimited access to the eight listed World Gym facilities, including fitness classes. Memberships do not include daycare fees.

• All program participants will receive a personal wellness profile report about two to four weeks after the enrollment period ends.

• Any gym membership for employees (or their family members) who ends their employment with CCPS will be terminated.

• Gym memberships do not renew automatically.

The goal of the program is to provide CCPS employees with opportunities to learn about healthy lifestyles and keep health care costs and claims low. ## Nominate an outstanding teacher for Post's award

Charles County Public Schools (CCPS) is accepting nominations for the *Washington Post*'s 2015 Agnes Meyer Outstanding Teacher Award. The annual award honors exemplary teachers who demonstrate excellence in teaching and outstanding leadership, encourage creative and quality instruction, and contribute in a substantive way to the improvement of education.

Nominees must be full-time teachers in grades prekindergarten through 12 and have a minimum of five years teaching experience. Three of those years must have been with Charles County Public Schools. Teachers, students, former students, administrators or community members may submit nominations. Teachers may not nominate themselves. Nominees must also maintain their teaching position throughout the 2015-16 school year.

Nomination materials must include a minimum of four statements of support, one of which must be from a professional educator; a career summary; a description of contributions in each of the nomination criteria categories, and a vertical headshot color photograph of the nominee (submitted both on a disc and printed out). These materials must be included in a presentation binder and not exceed 40 pages total.

Nominees must be teachers who:

• instill in students a desire to learn and achieve;

• understand the individual needs of students, encourage their talents and foster their selfesteem;

• demonstrate a thorough knowledge of subject matter and the ability to share it effectively with students;

• foster cooperative relationships with their colleagues and the community;

· demonstrate outstanding leadership; and

• maintain their teaching position throughout the 2015-16 school year.

Charles County's Agnes Meyer Outstanding Teacher Award recipient will be one of 21 recognized by the *Post*.

Nomination packets are due Friday, Jan. 30. Materials should be sent to Pam Mucciolo, Office of Human Resources, Charles County Public Schools, Jesse L. Starkey Administration Building.
